## **97<sup>th</sup> Annual California Golf Association Amateur Championship**

### **NCGA Association Membership Entry**

**Entries Close: March 19, 2008**

**Qualifying Date: April 21 or 28, 2008**

**Qualifying Sites: April 21:** Castlewood CC, Diablo Grande Resort, Visalia CC

**April 28:** Hiddenbrooke GC, The Olympic Club, Sierra View CC

**Championship Date: June 16-21, 2008**

**Championship Site: Oakmont CC (Glendale, CA) and Lakeside GC (Burbank, CA)**

**Eligibility:** A numeric index of 4.4 or less on the **March 1** Master Report. Players belonging to clubs in both Northern California and Southern California may submit an entry for both NCGA and SCGA qualifying but can only play in one qualifying round.

**Format:** Qualifying – 156 players (78 North/78 South) including exempts will advance to the championship proper. Championship – 36 holes of stroke play (18 holes per day) at Oakmont CC and Lakeside GC. Top 32 players will advance from stroke play to single elimination Match Play at Lakeside GC beginning on Wednesday and concluding on Saturday with a 36-hole match between the two finalists.

**Refund policy:** Requests for refunds received through March 28, 2008 (for qualifying) and June 6, 2008 (for championship) will be honored (less a \$25 handling fee) for contestants withdrawing from the competition. Requests for refunds after the above dates will not be honored.
