## 99<sup>th</sup> Annual California Golf Association Amateur Championship

**Entries Close: April 7, 2010**

**Qualifying Dates: April 26, May 3, or 24 in Northern California  
May 4, 11, 13, 17, 18, or 20 in Southern California**

**Championship Date: June 21-26, 2010**

**Championship Site: La Jolla CC & Rancho Santa Fe GC**

**ELIGIBILITY:** A numeric index of 4.4 or less on your club's Master Report at the time of entry. **Players may register to qualify in either Northern California or Southern California but may play in only one qualifying round.**

**FORMAT:** Qualifying -18 holes. 156 players including exempts will advance to the championship proper. Championship: 36 holes (18 holes per day) of stroke play. Top 32 players will advance from stroke play to single elimination Match Play beginning on Wednesday and concluding on Saturday with a 36-hole match between the two finalists.
