

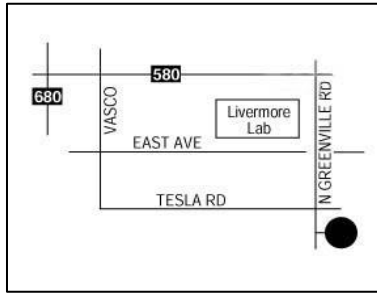

**PLAYER INFORMATION SHEET**

**FORMAT: 18 holes stroke play.** Play will be at 100% of the course handicap. Men will play from the **WHITE** tees; women will play from the **GOLD** tees. The number of qualifying spots available at each qualifying site will be determined based on the total number of entrants and the final field at each site. Final numbers of spots will be available from the Committee on the day of qualifying. Players will be playing to **September 1, 2010**

**Indexes.**

**RULES OF PLAY:** The **2010-2011** USGA Rules of Golf are in effect and are supplemented by the NCGA rules card. The committee will provide any additional Local Rules needed at the tee. It is the individual player's responsibility to know the conditions of the competition. The "One Ball Rule" is **not** in effect.

**GOLF CARTS:** Golf carts are optional at the player's expense. Cart rental is \$17 per person. **Spectator carts are prohibited.** A maximum of two carts per group is permitted.

**1ST TEE TIME: 7:00 AM.** Players should be at their assigned tee 10 minutes prior to their tee time.

**PRACTICE ROUND:** If you wish to play a practice round you must make reservations by calling the golf shop at the number listed above. Practice rounds are available to contestants within 3 days of the qualifier. Green fees are \$49, including cart, Monday through Friday. Normal NCGA member fees apply on weekends or holidays. Please identify yourself as a NCGA tournament contestant.

**WITHDRAWALS AND NO SHOWS:** See NCGA rules card. Players who have entered into a NCGA event and wish to **withdraw for any reason MUST notify the NCGA Rules and Competitions Department at (831) 625-4653.** You may call during regular business hours or between 5:00 PM and 8:00 AM and leave a message. **A player who does not show up and does not notify the NCGA shall receive a ONE-YEAR SUSPENSION FROM ALL NCGA EVENTS FOR THE CALENDAR YEAR FOLLOWING THE INFRACTION.** A player who only contacts the course and NOT the NCGA will incur the suspension.

**SUBSTITUTIONS:** Substitutions must be made by a club official prior to qualifying only. No substitutions after **5:00 PM on Thursday, September 2, 2010.**

**FOOTWEAR:** Non-metal spikes required. Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION**

**DRESS CODE:** See NCGA rules card.

**PLAY-OFF:** Ties will be broken by the USGA suggested method of matching cards.

**CERTIFICATES/CHAMPIONSHIP FEE:**

If you registered using a credit card, and are a qualifier, you will not be mailed a certificate. Your credit card will automatically be charged the \$130 Championship fee.

If you paid the registration fee with a check, and are a qualifier, a certificate will be mailed to you. If you have not received your certificate by Friday, September 17<sup>th</sup>, please contact us immediately. This certificate must be completed and mailed to the NCGA at the PO Box listed on the certificate with an additional \$130 by September 22, 2010.
