



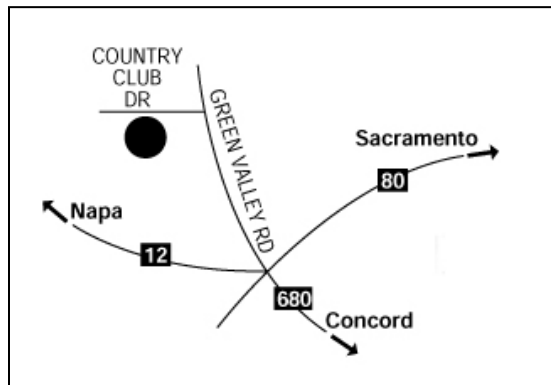
USGA WOMENS MID-AMATEUR CHAMPIONSHIP QUALIFYING

CONTESTANT INFORMATION SHEET

Listed below is IMPORTANT tournament information pertinent to the qualifying site where you have been assigned.

FORMAT: 18-hole stroke play. Contestants will play from the **WHITE** tee YARDAGE **except** where noted on the attached yardage sheet. Players will be advised as to the number of spots and alternates at their first tee on the day of the qualifier. Those who qualify will advance to the championship Sept 25-30 at Wichita Country Club, Wichita, KS. There will be a playoff immediately following play to determine the last qualifying spot and/or alternates if necessary.

QUALIFYING SPOTS: The number of spots available at each qualifying site will be determined based on the total number of national entrants and the final field at each site. The final number of spots will be available from the Committee on the day of qualifying.

CERTIFICATES: If you are a qualifier, it is important that you pick up your certificate from the Committee prior to leaving the qualifier.

RULES OF PLAY: The 2010-2011 USGA Rules of Golf are in effect and are supplemented by the enclosed USGA Hard Card. The Committee will provide any additional Local Rules needed at the qualifying or championship site. It is the individual player's responsibility to know the conditions of the competition. **The "One-Ball Rule" is in effect.**

GLOBAL POSITIONING SYSTEMS AND HAND HELD RANGE FINDERS are **NOT** permitted during USGA Championships and Qualifiers. Penalty - **DISQUALIFICATION**

AUTOMOTIVE TRANSPORTATION: **The use of automotive transportation is forbidden.** Players or caddies may only ride if transported by a member of the Rules Committee.

DRESS CODE: PLAYERS, CADDIES and SPECTATORS must be properly attired both on the golf course and premises of the club. Blue jeans, designer jeans, T-shirts and tank tops are prohibited. Collared shirts must be worn. Shorts, if worn, must be no shorter than mid-thigh (no jean shorts). **DRESS CODE IS THE SAME FOR MEN AND WOMEN.**

FOOTWEAR: Shoes with traditionally designed spikes (regardless of composition, i.e., ceramic) or spikes, regardless of design, comprised either entirely or partially of metal (when such metal comes in contact with the surface of the putting green) are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

PRACTICE ROUNDS: Practice Rounds are available any afternoon that the club is open during the weeks of August 16 and August 23. The club is closed on Mondays. Players must call in advance to make a tee time at 415-382-6707 and identify themselves as competitors in the qualifier. There will be no charge for a practice round, although cart rental will be charged. Practice rounds are for **CONTESTANTS ONLY; NO GUESTS.**

PRO SHOP & RANGE: The Pro Shop and driving range will open at 8:00 AM on the day of the competition.

FOOD SERVICE: Lunch will be available for purchase by contestants. **CASH ONLY.**

WITHDRAWALS & NO SHOWS: Notify the NCGA Rules & Competitions Office at (831) 625-4653.

REFUNDS: The USGA will refund the entry fees in the event of injury or illness, if requested by September 1, 2010. A \$25.00 service charge will be deducted from all refunds. No refunds for any reason after September 1.
